- 8. Sheila Morrison has a Starting Point 2023 book available for \$30. She went on to the Holiday Walk report. She thanked Bonnie Tucker and Gayle Klostermeyer for their assistance. We had 95 walkers including 80 for credit, 2 on coupons, 13 guests. The Harbor House was an excellent location for walk headquarters and should be secured again for the walk December 9th. Expenses exceeded income by \$79.76, but Bonnie pointed out that this is a service to the community which is a part of our mission. Consensus was to reserve Harbor House again.**
- 9. Cindy and Mike Extine have made arrangements with Westwood Baptist Church as walk headquarters for the Westside Trails Event March 25th. The Ralph Monroe trail**

should have blooming daffodils, so will be incorporated into the walk. They plan to create both a 5K and 10K walk.

10. Pam Grieg-Davis is developing the Earth Day walk for April 29 and has obtained a special discount admission fee to NorthWest Trek of \$15 for our walkers on April 30. The Trek ticket will only be available at this rate by advance registration. The Vance Creek Rail Riders event on July 22nd will be the noon start time for up to 40 riders.
11. Millersylvania State Park was suggested as a site for the August picnic. A motion was made to hold the annual picnic at Millersylvania, seconded and passed. The trails should be in good condition then for a nice walk. A Discover Pass or day pass is required for each car parking within the park.
12. Carol Froelich is investigating alternatives for an Anderson Island event.
13. Joy Adams volunteered to be trailmaster for the 2023 Holiday Walk. She will be assisted by Diane Evans.
14. Joy Adams is designing a 5K walk in LBA Woods. It was suggested that would be a good summer Tuesday evening walk site.
15. The board voted to purchase a Traveling Guided Walk Stamp again this year if it is no more than \$150.
16. Karen Younkens and Sheila Morrison are keepers of the CVC business cards and will bring them to future club meetings.
