1. Minutes of the 8 June 2021 membership meeting were approved.

- 2. The Treasurer's Financial Statement of 31 May 2021 was approved.
- 3. The CVC Annual Picnic will be held in Shelter #1 at Priest Point Park on 10 August 2021. There are no Covid restrictions on the Club's use of the facility. - 4. Planning continues on the Salmon Walk, scheduled for Saturday, October 2, 2021 at Tumwater Falls Park/Brewery Park/110 Deschutes Parkway. Registration begins at 9:45 AM with the walk at 10:00 AM. It was noted that the walk is currently shown as a traditional event on the NW Region Future Events List. This should be corrected to show it as a guided walk, which is how it is sanctioned.
- 5. Perki Sweet reported that on a recent walk in Shelton, only one of the Shelton park bridges appeared to be complete. Pam Grieg-Davis said that she would follow up with the Parks Department regarding the status of the work, sponsored in part by the Club.
- 6. Planning continues on the Multi-Day Event to be held April 22 to 24, 2022, and now named "Wild and Woodsy in Washington." The next planning meeting is August 26 at 7:00 PM. Walks during the event will be sanctioned for two weeks and will be on the Online Start Box. A series of Traveling Guided Walks, all starting at 10:00, will be used to proof new walks for the event:

- 8. Karen Younkins reminded everyone that CVC dues for the new year are currently due. Please give or mail checks, rather than cash, to Karen.
- 9. Nancy Wittenberg, the newly-elected Chairman of the Board for AVA, reported on the convention in Madison. She said that it was a well-run convention with lots of good walks. It was the first convention to be held in Madison and at the Monona Terrace Center since Covid, and as such it received a lot of publicity. Sharon Moats was awarded a Distinguished Service Award. There is a new slate of officers, except for the Secretary, and ten new board members. The next convention will be held in San Antonio, Texas in February of 2023 and will be a major international event, as it will be held in conjunction with the 18th IVV Olympiad.
- 10. David Black inquired how members could order Capitol Volkssport logo apparel. The last round of logo wear was apparently ordered in 2018 from Bud Bay Embroidery. David volunteered to pursue how the club can set up a new order.
