

CVC Board Meeting
February 12th, 2026

Those attending: Karen Younkings, President; Larry and Cheryl Bush, Vice Presidents; Pam Greig-Davis, Treasurer; Mary Clem, Secretary; David Black, ESVA Representative; Sheila Morrison, Membership Coordinator; and Barb Malone.

Topics discussed:

1. A reminder was given to Board members to let the Board know if you are planning to remain in your present role. Karen Younkings reiterated that she will resign and mentioned that Liz Morrison is continuing to look for a replacement. Positions are: President, Vice-President, Secretary, Treasurer, ESVA Rep. Appointed positions are Trail Master and Thursday Walk scheduler.
2. Will we continue Tuesday night walks? David mentioned that though they are not well-attended, they represent some of the only walks our club does that those still working can join in. It was stated that we need a new walk coordinator if we are to continue. Final decision TBD.
3. Progress on Wild and Woodsy: Pam stated that we will have 3 new walks: Tolmie State Park, a new Dupont walk, and a new walk out at Evergreen State College. There will be a pub crawl which will not encompass such a long walk, and visit fewer pubs. There will be a few group walks, including Millersylvania, and the Dupont walk. Advertising for the event will be put on our CVC website, the ESVA website, and Pam will arrange for it to appear on the AVA website. The pizza dinner on Friday in Hawk's Prairie will cost \$15, and the dinner at the Tumwater Valley Golf Club on Saturday will cost \$37. Sign-ups will be initiated at our March club meeting.
4. Items for sale (namely CVC club T-shirts,) will be brought to our March meeting. It was decided that they likely would not do a brisk business at Wild and Woodsy as most attendees are coming from outside our immediate area.
5. Susan Hennie and Gayle Klostermeyer have volunteered to be in charge of our August picnic. We have Squaxin Park reserved. We still need someone to volunteer to coordinate the Christmas party, which will be on Dec. 10th. After some discussion, it was decided to keep the party at the Jacob Smith House, and Pam will call to reserve, and send the deposit check.
6. Will we have another "Where the Salmon Run" walk this year? Barb agreed to speak with Birgit Miller as she had expressed interest earlier on.
7. It was reported that Pam has been given an introduction to our website and feels she is able to act as Peter's back-up.
8. Mary is planning to lead a walk in Bellevue in June on a Saturday, with exact date TBD. It will be a variation of the Lakehills walk that is managed by the Interlaken Trailblazer Club. There will be more information on the walk at the March Club meeting.
9. Mary had an idea for an Amtrak trip to Seattle, with a walk there, possibly the 5K Seattle downtown/waterfront walk managed by the Emerald City Wanderers, followed by a ferry ride to

Bainbridge Island and a walk to see the Dambo Troll. This would also likely be on a weekend, or possibly a Friday, as our Thursdays are spoken for. Other ideas always welcome.

10. The next Board meeting was scheduled for Tuesday, April 28th, at 2:30P.
